Maine Adult Use Cannabis Program Business Premises Delivery Consent Form

This Business Premises Delivery Consent Form must be completed by the owner, or other authorized agent, of a hotel or other private business before delivery of cannabis and cannabis products may be made to consumers at the hotel or private business by an authorized licensee of the Maine Adult Use Cannabis Program.

Statutory Guidance

The Cannabis Legalization Act appears in Title 28-B of the Maine Revised Statute, and the Adult Use Cannabis Program Rule, which provides rules to implement, administer and enforce the Act appears in 18-691 C.M.R. ch. 1.

- Pursuant to the above statute and rules, a Maine Adult Use Cannabis Retail Store:
- May only deliver cannabis and cannabis products between the hours of 7A.M. and 10P.M., or only on those days and hours during which retail sales are permitted by local regulation.
 - May only deliver cannabis and cannabis products to consumers who are 21 or older.
 - May not deliver cannabis and cannabis products to a hotel or other business located inside a drug-free safe zone as designated by a municipality.
 - May not deliver cannabis or cannabis products to a consumer at a hotel or other private business's premises without written consent.
